



THE 5th CONGRESS OF THE WORLD CONFERENCE OF CONSTITUTIONAL JUSTICE Information on Visa

A. VISA EXEMPTION FOR DIPLOMATIC AND SERVICE PASSPORT HOLDERS

Based on the agreement between the Government of Indonesia and several countries on Mutual Visa Exemption, the WCCJ member courts and invitees with Diplomatic/Service passport from the following countries are welcome for entry into Indonesia without a visa for maximum 30 days:

For entry without visa, all documents as mentioned in point D.3) to D.9) should be presented to the immigration officer upon arrival at the entry point. Kindly be reminded

that only those with all required documents will be given approval to enter Indonesia. The visa exemption for diplomatic and service passport shall allow delegates to stay for a maximum of 30 days during their visit to Indonesia.

B. VISIT VISA EXEMPTION

Indonesia has currently resumed Visit Visa Exemption facility which is at the moment limited for ordinary passport holders from ASEAN member countries only, until further notice.

For entry without visa, all documents as mentioned in point D.1) to D.10) should be presented to the immigration officer upon arrival at the entry point. Kindly be reminded that only those with all required documents will be given approval to enter Indonesia. The visit visa exemption shall allow delegates to stay for a maximum of 30 days during their visit to Indonesia.

C. VISA ON ARRIVAL SCHEME

The WCCJ Member Courts and invitees who hold Diplomatic/Service/Regular Passport from countries with no Mutual Visa Exemption Agreement with Indonesia, are eligible for Visa on Arrival (VoA) facility in Bali and Jakarta. In accordance with the Circular Letter of the Director-General of Immigration (DGI) Number IMI-0609.GR.01.01 of 2022 with necessary adjustments, the following nationals and special territory are eligible for VoA facility:

To obtain a VoA, participants shall meet the following criteria:

1. Able to present the following documents:

- 1) Ordinary Passport that will remain valid for at least 6 months beyond the date of entry to Indonesian territory;
- 2) Roundtrip tickets
- 3) Proof of payment for VoA (IDR 500,000)
- 4) Insurance, in accordance with the regulation from the Covid-19 Task Force
- 5) Invitation letter to attend the Congress issued by the WCCJ or/and the Host Court

2. Will arrive in Indonesia before October 4th 2022

Kindly be informed that this VoA scheme are not applicable for journalists

D. VISA APPLICATION AT INDONESIAN EMBASSIES/CONSULATES

Diplomatic/Service/Regular Passport holders of countries with no Mutual Visa Exemption Agreement with Indonesia shall apply for visa at the nearest Indonesian Embassy or Consulate, by presenting the following required documents:

1) Visa Application Form

2) 2 identical passport-style photos

Photos should be 4x6cm in size, portrait mode, with a plain white background, and printed on high-quality paper.

3) Official invitation letter from the WCCJ and/or the Host Court

4) Approved registration from the Secretariat for the 5th Congress of the WCCJ

5) Valid passport that will remain valid for at least 6 months beyond the date of entry to Indonesian territory, and contains at least 2 (two) blank pages.

6) Proof of return flight ticket to home country or other desired destination.

7) Card/certificate of a complete dose of Covid-19 vaccination

To qualify as fully-vaccinated, a person must have received all recommended doses in their primary series of Covid-19 vaccine, a booster dose is not required. The Indonesian government accepts Covid-19 vaccines within WHO Emergency Use Listings (EUL) as well as Gamaleya (Sputnik V), CanSinoBio (As5-nCov

(Convidecia)), Anhui Zhifei Longcom (Zifivax ZF2001), and BioKangtai (Kconecavac).

- If the person has not received full Covid-19 vaccination due to special health conditions or comorbid disease, this requirement can be replaced by obtaining and presenting a health certificate issued by a doctor from the government hospital of the country/region of origin of departure which evidenced the special health condition/comorbid disease of the patient and the reason why he/she is unable to receive Covid-19 vaccination.
- If the person has not received full Covid-19 vaccination due to a history of Covid-19 infection, this requirement can be replaced by obtaining and presenting a COVID-19 recovery certificate issued by a government hospital or ministry of health in the country/region of origin of departure;

9) Signed Statement Letter of Compliance of Covid-19 Protocol

10) Visa fee of Rp 2.000.000,00 for Visa application at the Indonesian mission

E. ONLINE VISA APPLICATION (E-VISA)

The WCCJ Member Courts and invitees who are regular passport holders, as well as Diplomatic/Service Passport holders located in countries where Indonesian Embassy/Consulate is not present, and nationals of countries that do not have diplomatic relation with Indonesia, shall contact the organizing committee at the earliest convenience in order to apply for e-Visa. Delegates who apply for e-Visa shall be required to disclose to the organizing committee the following required documents:

- 1) **Official invitation letter from the WCCJ and/or the Host Court**
- 2) **Approved registration from the Secretariat for the 5th Congress of the WCCJ**
- 3) **Copy of valid passport that will remain valid for at least 6 months beyond the date of entry to Indonesian territory, and contains at least 2 (two) blank pages.**
- 4) **Proof of return flight ticket to home country or other desired destination.**
- 5) **Card/certificate of a complete dose of Covid-19 vaccination**

To qualify as fully-vaccinated, a person must have received all recommended doses in their primary series of Covid-19 vaccine, a booster dose is not required. The Indonesian government accepts Covid-19 vaccines within WHO Emergency Use Listings (EUL) as well as Gamaleya (Sputnik V), CanSinoBio (As5-nCov (Convidecia)), Anhui Zhifei Longcom (Zifivax ZF2001), and BioKangtai (Kconecavac).

- If the person has not received full Covid-19 vaccination due to special health conditions or comorbid disease, this requirement can be replaced by obtaining and presenting a health certificate issued by a doctor from the government hospital of the country/region of origin of departure which evidenced the

special health condition/comorbid disease of the patient and the reason why he/she is unable to receive Covid-19 vaccination.

→ If the person has not received full Covid-19 vaccination due to a history of Covid-19 infection, this requirement can be replaced by obtaining and presenting a COVID-19 recovery certificate issued by a government hospital or ministry of health in the country/region of origin of departure;

8) Visa fee of Rp 2.000.000,00 for e-Visa application

Delegates shall kindly note that due to the increasing number of e-Visa applications to Indonesia, the e-Visa application process may take some time. Therefore, delegates are strongly advised to contact the organizing committee at least 28 days before the commencement date of the Congress to allow adequate time for the e-Visa application process.

OTHER IMPORTANT INFORMATION

1. All individuals entering Indonesia are **not required** to bring a health certificate declaring Covid-19 negative status. A health check will be performed by authorized health personnel at the airport, where an RT-PCR test will be conducted upon arrival if the individual exhibit symptom(s) of Covid-19 or if body temperature is detected above 37.5°C
