Health Protocol Regulations for International Travel During COVID-19 Pandemic
Based on the Circular Letter of the Indonesia COVID-19 Task Force Number 25 of 2022
and Visa Arrangement Update Based on the Circular Letter
of the Director-General of Immigration Number IMI-0650.GR.01.01 of 2022

A. Documents for International Travelers to Indonesia

1. International travelers are advised to download the [PeduliLindungi](#) app prior to departure. The use of the app is a mandatory requirement for international and domestic travels to and from Indonesia.
2. International travelers are required to show (physical or digital) card/certificate of the second dose of COVID-19 vaccination dated at least 14 (fourteen) days prior to departure, written in English in addition to the language of their country of origin.
3. The obligation to show COVID-19 vaccination card/certificate as referred to in point 2 does not apply to:
 - a. International travelers under 18 years of age;
 - b. International travelers with special health conditions or comorbidities that prevent them from getting vaccinated, on the condition that they show a medical certificate from a government hospital of the country of origin that states that the person concerned has not and/or cannot receive COVID-19 vaccine;
 - c. International travelers who have finished COVID-19 quarantine or treatment and have been declared no longer actively transmitting COVID-19 yet are unable to receive the second dose vaccination, on the condition that they show a COVID-19 recovery certificate or a medical certificate from a government hospital or Ministry of Health of the country of origin that states that the person concerned is no longer actively transmitting COVID-19;
 - d. Foreign nationals who hold diplomatic and official visas related to official/state visits of foreign officials at the ministerial level and above and foreign nationals entering Indonesia with the Travel Corridor Arrangement scheme, in accordance to the principle of reciprocity while still complying with strict health protocol;
 - e. Foreign nationals who have not been vaccinated and intend to travel domestically in order to continue travel with an international flight to leave the territory of

Indonesia are allowed to not show COVID-19 vaccination card/certificate as long as they remain within the airport area during transit while waiting for their international flight, on the following conditions:

- 1) Having a permit issued by the local Port Health Authority (KKP) to carry out domestic travel as a transit for flights to areas outside the territory of Indonesia; and
- 2) Showing a flight ticket to regions outside Indonesia for a direct transit from the city of departure to the international airport in the territory of Indonesia with the final point of arrival in another country.

B. COVID-19 Protocol at Entry Points

1. Upon arrival from international travel to Indonesia, international travelers are required to undergo an examination of documents as referred to in letter A.
2. After the document examination, international travelers are required to undergo an examination for COVID-19-related symptoms, including body temperature check.
3. In the event that the international travelers are detected to have COVID-19-related symptoms and/or have a body temperature above 37.5 degrees Celsius, they must undergo an RT-PCR confirmation test.
4. In the event that the international travelers do not have COVID-19-related symptoms and have a body temperature below 37.5 degrees Celsius, they are allowed to continue their travel and are encouraged to carry out independent health monitoring of COVID-19 symptoms for 14 days and comply with strict health protocol.
5. International travelers who have undergone an RT-PCR confirmation test as referred to in point 3 are allowed to continue their travel after taking a sample for the RT-PCR confirmation test and must comply with the following requirements:
 - 1) Waiting for the results of the RT-PCR test in hotel rooms, rooms at places of accommodation, or places of residence; and
 - 2) They are not allowed to leave the hotel rooms, places of accommodation, or places of residence and are not allowed to interact with other people before the results of the RT-PCR test show a negative result.
6. In the event that the RT-PCR confirmation as referred to in point 3 shows a positive result, the international travelers must be isolated/treated following the follow-up procedure for positive results.
7. In the event that the RT-PCR confirmation as referred to in point 3 shows a negative result, the international travelers are allowed to continue their travel and are encouraged to carry out independent health monitoring of COVID-19 symptoms for 14 days and comply with strict health protocol.

C. RT-PCR Testing for Opening Ceremony

Every delegate who will join the Opening Ceremony on October 5, 2022, which the President of the Republic of Indonesia will attend, are required to undergo an RT-PCR test on October 4, 2022, which will be provided by the Host Court. The location and time for the testing will be announced at a later date.

D. Visa Arrangement (Update)

Delegates from countries outside the [list](#) who hold **diplomatic and service passports** and those who have difficulty applying for a diplomatic visa or service visa due to the absence of an accredited Indonesian representative in their country of origin are allowed to take advantage of the VKSK/VOA (Visa on Arrival) arrangement to enter Indonesia.

Visa on Arrival can be issued after the following requirements are fulfilled:

- Passport that is still valid for at least 6 (six) months;
- A return ticket or a one-way ticket to continue travel to another country;
- Invitation letter;
- Proof of payment of PNBP for Visa on Arrival of IDR 500,000.00 (handled by the Host Court).
